As you may know, Regulation (EC) No. 1907/2006 of December 18th, 2006 about the Registration, Evaluation and Authorization of Chemicals ("REACH") and their restriction of use came into force on June 1st, 2007.

The company (1) WESTCODE (hereinafter referred to as the <Company>) represented by F. PORFIRIO (2) knows the obligations inherent to the REACH European Regulation, commits to proceed to a constant watch and inform without delay KWx of all events that could have an impact on the use of one of substances supplied by it.

The Company has taken all the necessary measures in order to ensure the compliance with the REACH Regulation of all the substances composing the raw materials or contained in preparation or articles sold to KWx (hereinafter referred to as <the Substances> , whether they are on their own or are contained in preparations or articles).

Therefore, the Company commits to justify that it has pre-registered or is about to pre-register within the time limit all the Substances or that it has verified that its own suppliers (European and Non-European) support this pre-registration duty.

Moreover, the Company commits to justify that the Substances are not subject to restriction or that they are not mentioned in the Candidate list of the Substance that are potentially subject to a previous authorization regarding their use: otherwise, the Company commits to inform the KWx and will propose, if necessary, an adapted alternate.

The Company will take all the necessary measures in order to provide with exhaustive and exact information (in particular all information with regard to SVHC) along and with all the documents required permitting the use of the Substances with all security and to satisfy all the regular obligations.

Furthermore, the Company, that certifies to have the following status (3): DOWNSTREAM USER regarding the Substances, commits:
